Cost: Accepted riders will need to pay \$60 for their stall. This will include two (2) weekend tickets. **This payment must accompany this application in the form of a club check.**

Horse & Rider Pairs coming to the MHF must meet the following requirements:

- *horse must have a current Coggins for April 19-22, 2018
- *horse must have record of current EHV vaccination (within 6 months of MHF)
- *horse must be spit polished to C1 HM Standards
- *horse must be in good body condition score of 5 (Henneke Body Condition Score)
- *horse must be in good riding condition and ready to perform.
- *horse and rider must stay on the MHF Grounds from Thursday, April 19th (exact time TBD by MHF schedule) through 5 PM, Sunday, April 22nd, 2018. NO EXCEPTIONS!
- *rider must have history of active participation in LSR activities over the past 2 years
- *rider must have a current concussion form on file with LSR
- *rider is required for set up and tear down.

*****Only Accepted Applicants are expected to participate with LSR. USPC and LSR will be counting on accepted horses and riders to fulfill our commitment to MHF. Only sickness or lameness, with medical/veterinary excuse, will excuse an accepted applicant after Feb. 15th*** Please apply seriously!**
